That for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations in hand paid first party by second party, the receipt whereof is hereby confessed and acknowledged, the party of the first part has sold, remised, released and quit-claimed and by these presents does sell, remise, release and quit-claim unto the party of the second part, its successors and assigns forever, the right-of-way for its telephone poles, pole-lines, wires, toll-lines and all appurtenances thereunto appertaining and belonging, including guy, anchor and brace wires for such poles and pole-lines, together with the right to construct, operate and maintain the same (with the right of entry for such purposes) over, along, across and upon the following lode and placer mining claims, to wit:

Surprise, Chippie, Valley View, Morning, Park Place,
Enterprise, Japan, Golden Treasure, Anaconda, Bonanza, and
Mikado,

and over, along, across and upon such other lode and placer mining claims as are now owned or may at any time hereafter be acquired by said party of the first part;

AND PROVIDED FURTHERMORE that the said party of the first part shall not be held liable for any loss, damages or injury to the poles, lines or wires of the said party of the second part, or to its business, unless the same shall result from the inexcusable negligence or carelessness of the said party of the first part.

TO HAVE AND TO HOLD the same, together with all and singular the appurtenances and privileges thereunto belonging, or in anywise thereunto appertaining, and all the estate, right title, interest and claim whatsoever, of the said party of the first part, either in law or equity, to the only proper use, benefit and behoof of the said party of the second part, its successors and assigns forever.
